All we need to sign you up is the following:-

- * Your Full Name
- * Contact Cell Number
- * Whatsapp Number
- * Email Address

The Bank Details is for us to pay your commissions in via EFT once the clients payment reflects.

Method of a sale

You approach a client who may be interested in either a new website or advertising in the online electronic magazine.

You explain to them about what the services and functions are of a website.

In that a website can promote their business and services to a wider market.

To advertise in a local newspaper or brochure will only give them a limited amount of exposure.

I.e. a local newspaper will cost +/- R300-00 for a business card sized advert which is displayed only on one (1) publication and may be seen by a few thousand readers.

Most people who read a newspaper or advert on paper just normally glance through it and that's it, gone forever.

Whereas on the internet, a person searching for a product or a service will be able to search globally or locally and depending on your website's effectiveness and information, this will be where the people will find your product or service.

If the client is happy with the offer and has selected the size of the package they want, they must then fill in the Order Form and send it back to us.

They can also attach proof of payment with it, or they can pay when we send them the invoice.

Our payment structures are based annually payable upfront for all website design and hosting.

The Electronic Magazine we can work on monthly, quarterly, 6 monthly or annual payments.

The client must also send us all artwork, pictures, information, etc., within 7 days or sooner for us to be able to work on the design etc.

Payment is strictly EFT or Cash Payment to our Business Bank Account Only. NO Cheques will be accepted.

All payments are based on the order form as being, basic web design, annual (yearly) web hosting, registration, and setup.

There are no monthly costs involved unless specified in writing and acknowledged by us and the client.

Our normal turn-around time for a website is 24 Hours depending on work load and whether the client has sent us all the information.

Once the website is finished designed and uploaded, we then submit the details to Google for SEO “Search Engine Optimization” and loading on to the search engine.

Remember that Google is a total separate entity and any listing on the search engines is entirely up to Google and not with us, and it depends on how long it takes to reflect on the search engines.

We do however promote all aspects to try and get the absolute best results.

Remember that Search Engines works on “Keywords” which is a breakdown of the company’s services and / or products.

I.e. A plumber in Klerksdorp, you would use all the various names of plumbing, taps, toilets, piping, area such as Klerksdorp, North West, etc.

Please note local .co.za domain registrations / renewals / transfers take normally 24 Hours.

However international domains such as .com etc. can take up to 7 days to finalize.

For any transfers of international domains, we do need specific information to process the order and this will lead to an EPP Key (A special password permitting us to transfer) will be provided to us to proceed.

All information must be supplied in MS Word or text format, pictures in JPG/GIF/PNG or any workable format.

Other documents such as forms or notices can be supplied in PDF which will be placed directly on the website.

Once the initial design is online, the client can then advise what they do and do not like, and we will do up to 3 major changes for the final product.

The client can also send us any minor changes or updates (within reason) on a monthly basis which will be done "free of charge".

Any major changes etc. will be charged at R75-00 per page (A page is equivalent to an A4 page).

Client can upgrade at any time during their contract period to a bigger package and just pay the balance/difference due on a pro rata basis.

At the end of a client's hosting contract, they can then decide on if they wish to renew their contract with us at the same, or do they just want Hosting Only with NO Updates, or do they want to transfer their domain and hosting to another service provider, or do they want to cancel their service totally.

All renewals, the clients will be notified 3 months prior to end of the contract and will be invoiced according to their requests.

Payment for renewals, etc., must be done no later than 30 days prior to the end of the contract.

As to the Sales Rep, your commission gets paid out the moment you have sent us the signed order form and the client has done the payment to us and is reflecting in our account.

It is also up to the Sales Rep to follow up with the client every now and then to see if they are satisfied still, if they require anything or maybe they may have a new referral for a new client for you.

It is commission based only. For each sale you bring in and the client has paid, you get your commission immediately.

Salary means you are working for me directly. I am trying to get people to work for themselves.

I have learnt that when I pay someone a salary they sit back and do nothing, at the end of the month they want their money.

But on commission based work, they need to do the work to bring in the client.

Besides our commission structures is a lot higher than what a salary would be.

How much do I get per client? 🤖

Our Commissions Start from 20% on the total sales for Web Sites and Advertising and you can earn more, with more clients.

ie, in 1 calendar month, if you bring in:-

- 1-10 clients = 20%
- 11-20 clients = 30%
- 21+ clients = 40%

This is based on the total 1st year sale that we invoice only.
So if the client orders a R4500- package and pays the account, you will get 20%.

How much is that 20--40%?

Our packages start from R1200-, R1850, R2500-, R4500-, R6500- per year.

So it will be 20% of any of these packages

Here you can see your commission base

If you sign up and the client pays, say 5 clients a day on the R2500- package, will mean 5x R500-
Commission = R2500- per day that you get.

All you need to do is get the client, sign them up on the order form, send it to me. I invoice the client, and as soon as I get the payment, you get your commission.

I do all the rest of the work with the client to finalise the order.
